Prevention & Education - The goal of our Prevention & Education program is to reach those at highest risk of HIV infection with proven intervention strategies, strong supportive messaging, educational materials and condoms. In 2015, we started a Syringe Services Program that provides sterile injecting and smoking equipment and proper disposal for people who inject drugs; overdose prevention education including Naloxone distribution and fentanyl test strips; and access to care and treatment for substance use. Our Syringe & Overdose Prevention Service program is the largest in Sonoma County serving over 4,000 people who inject drugs, along with their families and friends. Our program also serves people from neighboring counties, including Lake, Mendocino, Napa, and Solano counties.

PrEP (pre-exposure prophylaxis) - We are now a covered entity under the federal government's 340B Drug Pricing Program which enables us to work with a tele-health company to prescribe PrEP, pre-exposure prophylaxis. This is a way to prevent HIV and is up to 99% effective when medications are taken correctly. With PrEP, people who are HIV-negative can take a medication once a day, or an injection once every two months, to reduce risk of getting infected if they're exposed to HIV. This is in alignment with the National HIV/AIDS Strategy, and the State of California's Getting to Zero Plan. Our goal is to provide information and access to PrEP to all people in Sonoma County at risk for HIV.
